

SCI Supported Children at the Pavement Schools



Atma Vikash- nurtures *Personal Development* by sustaining a group of pavement schools near the slum areas in Kolkata. For the past 33 years, SCI has supported six schools for destitute children under the guidance of Ram Krishna Vivekananda Mission (RKVM). There are 30 students in each school who come from impoverished families who live in the nearby slums. SCI provides approx.180 children with healthy snacks and basic education for school readiness in these pavement schools.

Udbhas- shines a *Bright Light* for the children who receive various services in the SCI-supported school located in Jodhpur Park, Kolkata. The students of Udbhas attend tutorial in the morning before attending regular school. Some students, after graduation, have pursued careers such as food technologist, computer analyst, graphic designer, etc.

Path to Success

Titil Sarkar, a former student from Atma Vikash writes: "I belong to lower-middle-class family. My father was in a private company with minimal salary, and mother, a teacher of Atma Vikash, administered by Ramakrishna Vivekananda Mission Pavement School, sponsored by Street Children International, USA. I joined one of the schools of Atma Vikash, as I entered to first step of my school life. Playing with other children, learning with fun, having tiffin (which is given in school) together without any social, class or status discrimination. That was my first and major learning that has helped me in life till date. After passing from high School, due to merit-list, I was short listed for Government Scholarship and also short listed in Govt College for completing Engineering in Electrical. During Final semester I got a job in MNC from Centralised campus. Currently I am with that Organisation from last 7 years as a System Engineer, expertise in Microsoft Windows Products."

She describes the importance of education and support from SCI: "Today I can tell that I became a butterfly from a caterpillar. If I look back at my journey, I can see the lessons and learning that I got from my mother and the first school made my path smooth and easy. Sharing, caring and to revert something to society not only with money, but knowledge and correct direction can help a lot of caterpillars like me. I am always looking forward to more successful years of this initiative, so that where I am today, I want more kids can reach there cross more milestones. So many kids like me who were part this school are well established now."

Titil's journey is a symbol of hope to many children who are receiving the necessary nurturing and care at the SCI-supported schools: "Starting from pre-schooling, the organisation supports the children until they reach their goal and complete their education... From the bottom of my heart I am thanking the team at SCI for taking this initiative and running this project successfully. I will never forget that what I am today, the first step was this school. Thanks a lot for the support." Titil Sarkar



At **BALWADI** (Sarjan Foundation), children have the opportunity to learn at their own pace. They are encouraged to develop mathematical skills along with expression and articulation in four languages: English, Hindi, Gujarati, and Sanskrit.

Sarjan's vision is to create "a set of sensitive students who are physically, intellectually, culturally, and aesthetically developed."





Sarada Kalyan Bhandar provides educational activities, health care, and nutrition to children from rural communities. Children receive remedial coaching, study materials, clothing, nutritious refreshments. Classes on computer skills, spoken English, drawing, painting, music, sports, and yoga are conducted as a part of the daily routine that supports the mission of nurturing the underprivileged children.

2019 Annual Fundraising Event for Street Children International

Street Children International's annual fundraising program in 2019 included a multi-cultural event featuring music and dance performances by local artists. Handouts featuring the activities of SCI-supported schools were distributed to the attendees to raise awareness about SCI's mission. Testimonials from the pavement school children provided a glimpse into SCI's continued effort to support education, nutrition, clothing, and basic needs of well-being that ensures the children's survival in a cleaner and healthier way.
